Please return to Town Hall before your yearly renewal is due to prevent deactivation of your fob. Town Hall must be in receipt of a current rabies vaccination certificate at all times.

## Greenbrook Adventure Park Paw Park Rules

1. This park is for the enjoyment of our canine visitors.
2. Dogs must wear current County tags and have a current rabies vaccination.
3. Dogs must be leashed when entering and exiting the park.
4. All dogs within the fence must be off leash.
5. Aggressive dogs will not be allowed to remain in the park.
6. Dogs must be under voice control at all times (*i.e. they should come when called by their owners*).
7. Owners must be present with leash and in view of their dog at all times.
8. Dog feces must be picked up and disposed of by owner.
9. Owner must immediately fill in any holes dug by their dogs.
10. People food is prohibited inside the park.
11. The small dog area is recommended for small, fragile or elderly canine visitors.
12. In all cases, owners are responsible for the actions of their dogs.
13. Canine and human visitors enter at their own risk. Lakewood Ranch Community Development District 4 cannot be responsible for injuries to visiting dogs, their owners, or others using the park.
14. Aggressive dogs and dogs in heat are not allowed in the park.
